

## SpLenDed Call for Good Practices

### Frequently Asked Questions

#### WHAT IS THE CALL FOR GOOD PRACTICES ABOUT?

The SpLenDed project, co-funded by the Erasmus+ programme, has launched an open call for good practices, success stories, and lessons learned in relation to **inclusive and effective adult education provision to learners with SpLDs.**

The purpose of this call is to **highlight examples of good practices, including those that could be replicated or scaled-up by others across Europe.** The submitted practices may show how gaps and constraints could be addressed, and what steps could be taken to accelerate progress in the achievement of effective and inclusive adult education to learners with SpLDs.

Currently, secondary desk research is conducted from all SpLenDed partners in five countries from late January to end of February 2022, collecting good practices that fit evaluation criteria of relevance, impact, transferability and connectivity to SpLenDed CAF.

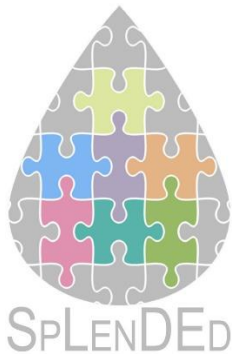
#### WHO CAN CONTRIBUTE?

Adult education providers from public, private and N.G.O./voluntary sectors, EU organizations, and field experts from all relevant sectors (education and health-wise) and EU regions can submit applications.

#### WHAT CAN BE SUBMITTED?

One or more examples of good practices can be submitted; for example learning materials, assessment methods, and ICT supportive environment, EU project testimonies – all should be directly related to the achievement of effective and inclusive adult education provision to learners with SpLDs.

Submissions should show inspiring breakthroughs, lessons learned, and success stories related to the implementation of effective and inclusive adult education provision to learners with SpDLs at national and regional levels.



#### HOW CAN I SUBMIT A GOOD PRACTICE?

Submissions can ONLY be made through a web-based form available at: <https://forms.gle/WQKG1QcKfgT9QECC8>.

The online form will be open from late January 2022 to **28 February 2022**.

We strongly recommend preparing the answers in advance.

In case a time extension is given, corresponding notifications will be posted on SpLenDed Facebook account and on the SpLenDed website.

#### CAN I SAVE AN UNFINISHED APPLICATION AND RETURN LATER TO CONTINUE WITH THE SUBMISSION?

Unfinished submissions might not be automatically saved. To avoid any possible information loss, it is STRONGLY suggested that submissions are prepared in advance and saved on a separate file before you start with the online form.

Only submissions through the online form will be accepted.

#### CAN I SUBMIT MORE THAN ONE GOOD PRACTICE?

Multiple good practices can be submitted by the same contributor as long as all required information is submitted for each practice.

#### WHAT TYPE OF INFORMATION SHOULD BE INCLUDED IN A GOOD PRACTICES SUBMISSION?

Submissions should include the title of the practice, geographical coverage, an introduction, the key stakeholders engaged, the results/outputs and impacts, replicability of the initiative, conclusions, contact details and other sources of information. Submissions will also be requested, provisionally, to explain how practices were (or not) impacted by COVID-19.
